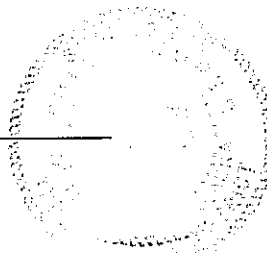

The Municipality of Anchorage, by and through its undersigned attorney, charges that on or about the 16th day of February, 2016 at or near 1310 1/2 Medfra Street Anchorage, Alaska, Esteban Santiago did commit the offense of: VIOLATION OF CONDITION OF RELEASE (DV), to wit: ESTEBAN SANTIAGO, while charged with a criminal offense, did knowingly violate or fail to adhere to any restrictions on travel, association, place of abode, or any other restriction or condition of release, with or without bail, imposed by any court in connection with such charge, which is in violation of Anchorage Municipal Code 8.30.110(A).

PC STATEMENT:

Defendant had conditions of release in pending case 3AN-16-278CR (Assault DV & Crim. Misch.) that included no-contact with the identified victim in that case, [REDACTED], and not to go to or be at her residence without a police civil standby. During a compliance check, APD officers found Defendant at the residence in violation of the latter condition. Defendant admitted he had been at the residence -- and with [REDACTED] -- in violation of his conditions since he had been released from custody on or about January 17, 2016 in the pending case.
