While driving southbound on Pine at Franklin at 0213, I heard what sounded like one gunshot coming from the west. I continued south on Pine, went east on Vine, north on Madison, and turned west on Franklin. I heard 8-12 gun shots in rapid succession coming from the west. As I crossed Pine, I saw a gray SUV northbound on St. John's. When I got to the intersection of Franklin and St. John's, a (unknown) male was vigorously pointing at the SUV. I followed the SUV which turned east on Albert, north on Pine, and rolled through the red light turning east on Kibby. I followed the vehicle, which was being operated on a flat tire. Additional officers got behind me as we crossed sugar. The SUV turned north on Collins. I initiated a traffic stop. The driver, Michelle McLellan, put her hands out of the driver's window. She yelled there was a gunshot victim, Rico Glenn, in the back seat. I had Ms. McLellan exit the vehicle. Other officers approached and checked the back seat of the SUV. She refused to do so arguing and cursing. She was told she was now being disorderly and to leave due to her disrupting an emergency scene. She again refused to do so. She was fighting and screaming as loud as she could. Officers were now completely exposed to the house attempting to arrest Brittany. We had to force her against her car to gain her compliance. I told her numerous times to "stop." She would not comply and actively fought with officers. She was hard to grab due to her small stature and she was tialling every part of her body. At one point due to Brittany screaming and fighting with officers the war able to get partially turned around punched me in my left eyebrow. I told her she just puncted me. She still would not stop fighting with officers and would not stop her behavior and violent demeanor and was now inciting the crowd that was growing. Brittany was kicking at officers and while doing so kicked her sandals off. After numerous attempts we were able to gain control of Brittany. Even though Brittany actively assaulted officers we attempted to refrain from taking her
