Dear Mr. Trice:

EPA Region 1 issued a National Pollutant Discharge Elimination System (NPDES) Permit for Pilgrim Nuclear Power Station (PNPS) (NPDES Permit No. MA0003557) to Holtec Decommissioning International ("Holtec" or "Company") in January 2020. The 2020 NPDES permit excludes the discharge of certain wastewater. Our understanding from EPA Region 1's Water Division is that while discussions regarding permit coverage of wastewater discharges related to decommissioning activities, including wastewater from spent fuel pool water and other sources may be ongoing, EPA has not received an application for such coverage or an explicit confirmation that Holtec will submit one.

At a November 28, 2022, public meeting, when asked if there would be "no discharge prior to resolution of the permit issue," Compliance Manager David Noyes said, "I can't say that." Later, when asked whether Holtec would provide advanced notice of a discharge Mr. Noyes responded, "I'll have to get back to you." Region 1 has already provided Holtec with written notice that "discharges of pollutants in water stored in the spent fuel pool, dryer/separator pit, torus, or reactor cavity are not authorized under the current NPDES permit."¹ Such unauthorized discharges would be a violation of the Act and could subject the Company and its agents to the full array of enforcement authority that Congress has granted to EPA in Section 309 of the Act, 33 U.S.C. § 1319.

Among EPA's duties is the responsibility to ensure compliance with the Act. Representations by the Company at the November 28, 2022, meeting appear to contemplate the possibility of intentional *noncompliance* with the Act without prior notice. With this letter, EPA is hereby requiring Holtec to provide notification well in advance of any planned discharges of CWA-regulated pollutants not authorized under the facility's 2020 NPDES Permit, including industrial wastewater stored in the spent fuel pool, dryer/separator pit, torus, and/or reactor cavity. Advance notification would allow EPA to take all appropriate action to ensure that federal law is being duly observed. To be clear, this notification/reporting obligation should not be interpreted by Holtec as authorizing such discharges. To the contrary, as stated above, this additional

obligation is to ensure that EPA has adequate time to take appropriate action to ensure compliance with the Act

Section 308(a) of the Act, 33 U.S.C. § 1318(a), authorizes EPA to require the owner or operator of a point source to provide information needed to carry out the objectives of the Act. Under that authority, EPA hereby requires Holtec to identify: i) the specific days and times that it intends to discharge any stored spent fuel pool, dryer/separator pit, torus, reactor cavity, or other decommissioning-related wastewater from the decommissioned Pilgrim nuclear power plant in Plymouth; ii) the precise tanks and other storage vessels from which any wastewater covered under i), above, is to be discharged along with the precise structure through which the wastewater is to be discharged; and, iii) the planned volume of any wastewater covered under i), above, to be discharged each day.

Such notice must be provided electronically to David Turin, Enforcement Officer, at <u>turin.david@epa.gov</u>, at least 90 days prior to commencing such discharges.

Compliance with this information request is mandatory and the requirement to provide the requested information is ongoing. Failure to respond timely, fully and truthfully, or to adequately justify any failure to comply with the requirements set forth herein, constitutes a violation of the federal Clean Water Act. In addition to administrative and judicial civil remedies available for such violations, including penalties and authority to compel compliance, under Section 309(c) of the Act, 33 U.S.C. §1319(c), anyone who knowingly violates Section 308 the Act, or who knowingly submits false material statements or representations in documents or reports required under the Act is subject to criminal fines, imprisonment or both.

EPA reserves the right to request further information from the Company regarding any information in its possession relating to plans to discharge CWA-regulated pollutants into Cape Cod Bay without first obtaining an NPDES permit, including any potential associated economic benefit accruing to the Company from that decision.
